DIRECT PURCHASER PLAINTIFFS' UNOPPOSED MOTION TO EXTEND THE DEADLINE IN PARAGRAPH 26 OF THIS COURT'S JUNE 26, 2024 ORDER REGARDING DPPS' SANDOZ SETTLEMENT

Pursuant to Federal Rules of Civil Procedure 6(b)(1)(A) and 23(d)(2), Direct Purchaser Plaintiffs' César Castillo, LLC, FWK Holdings, LLC, Rochester Drug Cooperative, Inc., and KPH Healthcare Services, Inc. a/k/a Kinney Drugs, Inc. ("DPPs"), by and through their undersigned counsel, respectfully move this Court to extend the deadline in Paragraph 26 of this Court's June 26, 2024 Order Regarding DPPs' Sandoz Settlement [MDL Doc. No. 3021] ("Sandoz Preliminary Approval Order" or "June 26, 2024 Order").

Specifically, DPPs move to extend the deadline for counsel to move for fees, expenses, and service awards provided for in Paragraph 26 of the Sandoz Preliminary Approval Order. As described in more detail below, extending the foregoing deadline will not require the Court to reschedule its March 17, 2025 Final Fairness Hearing or otherwise amend the June 26, 2024 Order. DPPs have conferred with Settling Defendants Sandoz Inc. and Fougera Pharmaceuticals Inc., who have affirmed that they do not oppose DPPs' requested relief.

I. ARGUMENT

This Court entered the Sandoz Preliminary Approval Order on June 26, 2024, thereby setting a schedule for proceedings that culminate with a Final Fairness Hearing on March 17, 2025. *See* Sandoz Preliminary Approval Order ¶ 23. In accordance with that Order, on July 10, 2024, DPPs caused Notice of the Sandoz Settlement to be disseminated to the Settlement Class. *Id.* at ¶¶ 16-18 (requiring Notice within 14 days of June 26, 2024). Under the Sandoz Preliminary Approval Order, DPPs currently must move for fees, expenses, and service awards by August 23, 2024. *Id.* at ¶ 26 (setting deadline as within 45 days of Notice). DPPs respectfully ask the Court to extend the August 23, 2024 deadline for a motion for fees, expenses, and service awards until September 23, 2024.

DPPs' requested relief will provide counsel with additional time to prepare what will likely be the first fee application that any party in this MDL presents to this Court. With the additional time requested, DPPs will be better able to prepare a more fulsome and detailed fee application that contains the information this Court will likely wish to consult when rendering possibly its first opinion on fees in this long-running and complicated MDL. All other deadlines related to the Sandoz Preliminary Approval Order would remain unchanged.

The limited, proposed change to the schedule will not infringe the rights of members of the Settlement Class. DPPs' motion will be filed and posted on the settlement website in advance of the October 8, 2024 deadline for class members to decide whether to opt-out or object to the terms of the Sandoz settlement. *See id.* at ¶¶ 19, 25. Moreover, per the form of Notice approved by the Court, each member of the Settlement Class already has notice that, "[f]or purposes of the objection and opt-out deadline of October 8, 2024, Settlement Class Members should assume that Settlement Class Counsel will seek attorney's fees of up to one-third of the net Settlement

Funds to date, after expenses and service awards have been deducted and including interest (and including the Settlement Funds from DPPs' prior Settlements)." Additionally, Members of the Settlement Class received Notice that DPPs' request for reimbursement of expenses shall not "exceed a total of \$2 million" and that service wards for the class representatives may be "up to \$20,000 each." Finally, the Notice also explained that "Settlement Class Members will have the opportunity to review, and object to, Settlement Class Counsel's motion for attorneys' fees after it is filed and before the Court rules." Therefore, Members of the Settlement Class will have the information they may need to render a decision by the October 8, 2024 deadlines.

Accordingly, DPPs respectfully request the foregoing extension to ensure adequate time for DPPs to prepare a fee petition. Should the Court grant DPPs' requested relief, within five days of such Order, DPPs will post a conspicuous notice on the Settlement website alerting the Settlement Class of this scheduling change. *See* Exhibit A (showing highlighted notice to be published on homepage of settlement website).

II. <u>CONCLUSION</u>

For the foregoing reasons, DPPs respectfully request that this Court enter the attached Proposed Order granting this Unopposed Motion.
